SUMMER AID REQUIREMENTS

- 1. You must be an admitted student at Seattle Pacific University (SPU) and working towards a degree.
- 2. Submit a 2021-2022 FAFSA application (if not submitted already). This must be received by SPU with a complete file before summer aid can be awarded.
- 3. Submit this Undergraduate Summer Aid Application to Student Financial Services (SFS).
- 4. To receive Federal Direct Loan funding, students must be enrolled in a minimum of six (6) SPU credits.
- 5. Pell Grant eligible students must be enrolled in a minimum of one (1) credit.
- 6. WA State College Grant & College Bound eligible students must be enrolled in a minimum of one (1) credit.
