**What is an official confidential financial statement?**

**Acceptable**

- An original bank statement indicating sufficient funds in **U.S. dollars** to cover the cost of one year of tuition plus room and board (i.e. \$39,000 U.S.)
- A letter **sent directly from the bank** indicating that the account holds a sum equivalent to \$39,000 in U.S. dollars.

**Not Acceptable**

- Photocopies or faxes of bank letters or bank statements
- Letters indicating "good customer" or "adequate funds", but does not indicate a specific amount.

**Important: Always indicate the name of the student on any financial statements so it can be paired with the correct application.**
