Other certification programs are not eligible for federal financial aid.
2. You must be enrolled each quarter in a minimum of six SPU credits if you are a post-baccalaureate student or three SPU credits if you are a graduate/doctoral student. Only courses that count toward your degree/certificate requirements are eligible for financial aid.
